

## Customer Privacy Policy for Residents of AK, CA, IL, MD, ND, VT

### What does Ownable do with your personal information?.

**Why?** Rent-to-own companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

**What?** The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Transaction history and account transactions
- Payment history and employment information

**How?** All rent-to-own companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons rent-to-own companies can share their customers' personal information; the reasons Ownable, LLC chooses to share; and whether you can limit this sharing.

### Reasons we can share your personal information

<b>For our everyday business purposes</b>

### What we do

<b>How does Ownable, LLC protect my personal information?</b>
To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. See our Website Privacy Policy for additional information.
<b>How does Ownable, LLC collect my personal information?</b>
We collect your personal information, for example, when you <ul style="list-style-type: none"><li>• Open an account or Use your credit or debit card</li><li>• Pay your bills or Give us your income information</li><li>• Provide employment information</li></ul> We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.
<b>Why can't I limit all sharing?</b>
Federal law gives you the right to limit only <ul style="list-style-type: none"><li>• Sharing for affiliates' everyday business purposes—information about your creditworthiness</li><li>• Affiliates from using your information to market to you</li><li>• Sharing for nonaffiliates to market to you</li></ul> State laws and individual companies may give you additional rights to limit sharing.

### Definitions

<b>Affiliates</b>
Companies related by common ownership or control. They can be financial and non-financial companies. <b>Ownable, LLC has no affiliates.</b>
<b>Nonaffiliates</b>
Companies not related by common ownership or control. They can be financial and non-financial companies. <b>Nonaffiliates we share with can include banks, mortgageors, lenders and loan brokers, lead generators, and prepaid card providers.</b>
<b>Joint marketing</b>
A formal agreement between nonaffiliated companies that together market financial or non-financial products or services to you. <b>Our joint marketing partners include banks, mortgageors, lenders and loan brokers, lead generators, and prepaid card providers.</b>
